- Information on the recruitment was also distributed internally to colleagues within BCC who may know of any young people, youth workers or youth groups in Belfast who may be interested. These included:

- The Corporate Communications Team compiled a range of short videos, mainly for social media, and took a wide range of promotional photographs to promote BCYC. There were boosted posts on Facebook and age targeted advertisements on Belfast Live for 2 weeks to promote the recruitment drive.

All applicants were invited to attend an information session and subsequently a short informal interview over Microsoft Teams.

In total, 38 young people attended for an interview and were successful in obtaining a place on Belfast City Youth Council. The breakdown in relation to DEA's of these young people are as follows:

- BCYC members will be agreeing their new areas of new work over the coming months. It is also anticipated that they will carry on some work on the previous legacy campaigns such as 'Elephant in the Room' mental health research, 'Any Use?' research into RSE in Belfast and 'Minor Choices, Major Voices' research into the experiences of BAME young people in Belfast.

Item 3: Rebranding update

Members will recall that at June 2021's meeting, with the then Belfast Youth Forum, it was agreed that Belfast Youth Forum would rebrand to become 'Belfast City Youth Council'. At this meeting it was agreed that the benefit of this rebranding had the potential to make the group's position at a city level more distinct and would provide a better linkage and connection with Belfast City Council.

This rebranding has taken place under the guidance of Corporate Communications team. New logos and social media graphics and handles have been created and are now in operation. This was promoted on both the BCC and BCYC social media platforms, on interlink, in City Matters and in a press release which featured the rebranding and the recruitment campaign. Any branded merchandise, communications and published reports going forward will feature the new graphics.

	<p>It was also agreed in June 2021's meeting that a celebration event would be held for new and previous Youth Council members and their families to celebrate the rebranding and to welcome the new members. Due to current legislation around social distancing for CoVid-19 and the limited use of some of the rooms in City Hall, it has not been possible to make any further arrangements on this at this time. Currently, the BCYC have use of the Reception Room once per month for campaign work and will hold their Youth Council meetings, which would have previously been held in the BCC Chamber, over Microsoft Teams. This arrangement is in place for all of 2022 or until CoVid-19 restrictions are relaxed.</p>
3.4	<p>Item 4: Youth Champions Members will recall that at June 2021's meeting, it was agreed that there was potential to improve communications and co-operation between Councillors, Officers and Belfast City Youth Council and that this could be done via the nomination of one representative from each political party to take a leadership role in working and engaging with the Youth Forum on issues and/or motions which relate to young people. At that time, the Neighbourhood Services Manager agreed to progress this through the Party Leader group. Unfortunately, due to sickness absence, this has not been progressed as yet. This will be progressed as soon as the NSM returns or will be followed up by an appropriate NSM designate.</p>
