Purpose of report

The purpose of this report is to introduce the presentation from the Greater Shankill Partnership Board regarding proposals for the creation of the Greater Shankill Greenway.

Relevant Background Information

The Committee is reminded that, at its meeting on 12th June, it agreed to receive a presentation from the Greater Shankill Partnership Board in respect of proposals to create a Greater Shankill Greenway.

The Partnership Board has commissioned work regarding a greenway following the publication of the Strategic Regeneration Framework for the Greater Shankill Area. This work has focused on realising the potential natural assets which surround and run through the Greater Shankill, such as Belfast Hills, the Ballygomartin and Forth rivers.

The proposed greenway would link the Belfast Hills and the City Centre, by travelling up the Shankill Road and then branching towards (1) Woodvale Park and its adjacent lands around Paisley Park and Springvale towards the Springfield Road and (2) to follow the courses of the Ballygomartin and Forth Rivers towards the Belfast Hills.

The initial feasibility study has been completed by the Paul Hogarth Company, who also carried out the work on the Connswater Community Greenway project. The Partnership Boards wishes to present the findings to the Committee and to seek to commence engagement with the Council.

The purpose of this report is to introduce the presentation by Consarc consultants regarding the feasibility study of options for refurbishment of the Floral Hall.

Relevant Background Information

The Committee is reminded that, at its meeting on 12th August, it agreed to receive a presentation from Consarc Consultants regarding the future of the Floral Hall. The Committee is further reminded that, following discussions between the Council, the NI Tourist Board and the Belfast Building Preservation Trust, it was agreed to revisit the 2004 business case in respect of the Floral Hall.

To bring the project up to date Consarc was appointed to undertake a review of the original 2004 business case and to consider the feasibility of restoring the Floral Hall in a sustainable way. This initial piece of work has now been completed and it is proposed that the Committee receive a presentation outlining the conclusions of the report and be given an opportunity to ask questions and comment upon it.

It is intended that a further report will be brought in October outlining recommendations as to future actions and next steps in respect of the Floral Hall.

Purpose of report

The purpose of the report is to introduce the presentation by the Ligoniel Development Association regarding the work of the Association; its proposals for environmental improvement in the area and the relationship with the Council.

Relevant Background Information

The Committee is reminded that, at its meeting on 10th June, it agreed to act as a third party partner and to provide funding of £5,122.57 to support Phase II of the Ligoniel Environment and Heritage Project. The focus of Phase II of the project is the creation of a community asset which will provide natural access to the hills. The total cost of the project is £51,225.67 and the Association has made an application to Biffaward for funding. The Committee also agreed to receive a presentation from the Association regarding its work, its plans and its relationship with Belfast City Council.

The Association wishes to open up the area to the general public as a major community recreational resource and been involved in a series of projects over the years, working with the Council and others to:

- 1. raise environmental awareness;
- 2. build stronger community cohesion;
- 3. increase the potential for social economy enterprise (e.g. eco tourism); and
- 4. increase individual capacity (volunteering).
