Reconsidered Items - Application Withdrawn

The Committee noted that the application Z/2014/0363/F, which related to 703 Lisburn Road, had been withdrawn at the request of the Planning Service to enable amended plans to be considered.

Reconsidered Item - 22 and 23 Shaftesbury Square

The Committee considered further a planning application for the change of use of ground floor premises at 23 Shaftesbury Square. That proposal would, if permitted, allow for the amalgamation of 22 with 23 Shaftesbury Square for use as an amusement arcade. It was noted that the Divisional Planning Manager had offered an opinion to approve the application.

A Member pointed out that the proposal, if permitted, would be contrary to the Council's Amusement Permit Policy, and, specifically, the criteria which related to:

- the cumulative build-up of amusement arcades in a particular location; and
- the impact on the image and profile of Belfast.

Therefore, on the grounds stipulated, she suggested that the Committee should reject the opinion of the Divisional Planning Manager.

After discussion, the Committee agreed, with two Members voting against, to adopt the opinion of the Divisional Planning Manager to approve the application.

(As the decision was not unanimous, it was subject to ratification by the Council.)
