inform members of a communication received from DfC on 1 June 2023 giving Council's 3 months' notice, ending the Council's role in the administration of the Affordable Warmth Scheme on 31 August 2023 (Appendix 2). 2.0 Recommendations 2.1 The Committee is asked to: Consider the request from DFC to sign the interim SLA provided for the period 1 April 2022 to 31 March 2024, acknowledging that the DfC have put the Council on notice terminating the arrangement on 31 August 2023. Main report 3.0 Key Issues & current position 3.1 DfC have provided Councils with an interim SLA for period from 1 April 2022 until 31 March 2024 (Appendix 1), which will bring the Affordable Warmth Scheme to an end with the intention that it will be replaced with another scheme. 3.2 On 1st June 2023 the Council received a letter from the DfC giving 3 months' notice of the termination of the Council's administration role within the Affordable Warmth Scheme. The 3 months' notice period will be from 1 June 2023 until 31 August 2023, during which time BCC will continue to provide 20 referrals per month (Appendix 2). 3.3 The Affordable Warmth Scheme will continue to run until 31 March 2024 but will be administrated by NIHE. It will no longer be a targeted scheme but will be managed through an application process. 3.4 The DfC and NIHE are developing comms and processes to inform Council's, existing applicants and interested applicants how the scheme will continue beyond 31 August 2023. 3.5 Building Control have 3 employees who carry out the administration of the Affordable Warmth Scheme, they will return to their substantive posts from 1 September 2023. Current position for the 2023-2024 year 3.6 To date this financial year 40 referrals have been sent to NIHE, with a further 60 allowed from June-August. 3.7 At present we are transferring the highest priority cases based on the matrix, but also have 540 residents who are eligible for the scheme but have not been submitted to date, given the number of referrals permitted. In addition, there are a significant number of residents who may be eligible

	for replacement windows but are unlikely to be considered given the higher priority cases in		
	Belfast.		
3.8	During the notice period work will also be undertaken to transfer this information to NIHE who are		
	still to confirm how these will be taken forward in the new application process.		
3.9	We have also referred 405 residents to other providers such as National Energy Action.		
	Financial & Resource Implications		
3.10	Councils will continue to be paid for 20 referrals per month for June, July and August and are		
	to receive payment for referrals submitted in April and May. The impact of this decision will be a		
	reduction in income of £30,000. However, the Council have been subsiding the Affordable Warmth		
	scheme through staff resources and with the scheme transferring to NIHE there will be an overall		
	saving of £50,000 to Belfast City Council.		
3.11	There may be a requirement to retain 1 employee for a short period of time to ensure the transfer		
	of applicant details which are held on an expression of interest list and to finalise the close of the		
	BCC role in the scheme.
