Relevant Background Information

Over the last decade and a half Belfast City Council has developed an annual programme of events. These events span the calendar year from a St Patrick's Day concert and parade in Spring to a New Year's Eve concert at the end of December and includes major sporting events (see Appendix 1). The events attract over a quarter of a million people, generating up to £6 million additional economic activity for Belfast.

The proposed annual budget for these events for 2009/10 would be £1,842,050. In 2007/8 the return on the Council's investment was just under £3 of every £1 of the city's finances. The events have also attracted on average of 15% of out-of-state visitors adding to the vibrancy and cultural activity of Belfast. The programme also operates as an attraction to local citizens and rate payers providing large-scale free public events to the province's capital with extensive positive media coverage, while receiving an approval rating of 89% for the entire year's programme of activities.

Key Issues

Breakdown of Events

Appendix 1 indicates the overall general events programme which is primarily based around key public and celebratory holidays and major sporting events including the Belfast Marathon. Within Appendix 1 there is a detailed breakdown of all Council expenditure on events, including funding via the Support for Sport scheme.

Events Strategy

Members are aware that a new integrated events strategy is currently being developed. This will assist Council in considering the overall programme content, its objectives and future direction. Approval is requested for the 2009/10 year in advance, given the 9-12 months lead in time required for successful event planning and management.

Resource Implications

Financial

Appendix 1 indicates the annual civic and sports programme with each individual events budget. The total overall budget for this programme is £1,842,050. This is the annual budget for events run by the Council, it is not new money and is beneath the 3% inflationary guidelines set by the Council. In addition all funding exists within the Department's annual finances.

Human Resources

There are currently no additional staff requirements.
