Glencairn Resident's Group

Glencairn Resident's Group has stated their in-kind costs cover electricity and heating but have not allocated an actual amount of money to this budget heading. It is estimated that the amount of money represented in kind by these core costs would not meet the minimum 20% match funding requirement. Therefore, this application is ineligible.

The Basement

This application contains no appendices bar the constitution. Within the application it does not say how much they are requesting from BCC. In-kind costs do not represent the 20% match funding needed, neither does it state what the in kind costs are. Therefore, this application is ineligible.
