- There are also plans for a quality framework for public services on the EU-level.
- Adoption of the draft <u>directive on patients' rights</u> and start of the implementation process.

- Consider the opportunity for BCC to sign the Green Digital Charter to open up future funding possibilities
- Two reports have been produced providing highlights, key learning, web links and contacts made at these events. This information has been disseminated among BCC colleagues to inform their work and to provide follow up contacts
- ISB have confirmed interest in attending KSF and will commit to attending 2 to 3 working groups in 2011

- Dave Carter, head of Manchester Digital Development Agency and lead of one of the KSF working groups met with BCC staff in Belfast to outline the benefits of being involved with Eurocities and to share his learning
- Dave Carter provided invitations for BCC staff to attend a New Generation Access event at the Titanic Quarter
- Manchester is interested in learning more about BCC's 'chipped bin' service
- Attend two KSF Forum meetings:
- 1) Linkoping June 2010: The theme of the conference was how to plan and build sustainable, desirable cities. Key learning points:
- the need to think global and act local and consider 'growing the home' as the basis for ecological, social and economic sustainable development
- Importance of creative/innovation space and collaboration between sectors and functional networks
- Use of Urban Atlas, Urban audit and visualisation tools to engage, inform and influence policy and decision making
- The possibilities ICT presents in reducing Co2 emissions turning waste into energy and fuel
- 2) Birmingham October 2010: This conference focused on the EU Digital Agenda. Key learning points:
- The Smart Cities Working Group led by Dave Carter of Manchester Digital Development Agency (DDA) has influenced the allocation of Framework Programme 7 funding and there is now a line written into the 7th framework programme to support actions relating to the Eurocities Smart Cities work. Manchester DDA, Clicks and Links and a Technical Institute will submit a bid which if successful will enable signatories of the Green Digital Charter to access help to enable them to reduce carbon emissions through pilots such as piloting smart metering. This could be of benefit to BCC and its partner organisations.
- Cities need to be proactive in working with universities and research centres to put themselves forward as test-beds to pilot new initiatives and to work in partnership to draw down EU funding. It has been recommended that cities join as partners rather than leading on bids until they gain reasonable experience
- Two new working groups have been suggested which are of interest to BCC, these focus on the services directive and open data sharing.
- Venice are developing a bid re policy modelling under FP7.

This Forum links to and supports work in the Development Department and in particular the Tourism, Culture and Arts Unit. In addition there is also benefit for Parks and Leisure as this Department controls some tourism facilities including the Zoo and Parks including Botanic Park. It also links to the work of Belfast Visitor and Convention Bureau and Belfast City Centre Management.

(A) Outputs and Achievements for 2010:

Note: BCC to date has not engaged formally in this forum but maintained a watching brief for relevance to the work of BCC in 2011. Initial engagement has led to the following awareness and information, and BCC has had the opportunity to:

- Receive up to date information on EU policy and take part in a range of consultations
- Receive information on the Cultural Issues and developments and consider their implications for Council and Belfast
- Be aware of funding developments to support work such as Culture Programme, Interreg IVB and Youth Programme
- Consider partnering opportunities
- Network to learn from the experiences of others and to exchange experience
- Develop relationships with others to create a contacts base for the development of potential future projects
- Profile the work of Belfast resulting in Belfast being recognised nationally and internationally as a leisure and business destination
- Take part in debates, surveys and stakeholder groups to influence policy and to feedback on implementation
- Take part in discussion to influence the set up of new working groups through the Forum
- Attend Culture Forum Events

A Members' survey conducted during 2010 clearly outlined members' priorities for 2011 and this was the basis for the formulation of the 2011 work programme. A new electronic culture monthly update was launched in 2010 and will continue in 2011 and will be a tool for member cities

to use to promote specific initiatives or events related to culture in their cities.

In 2010, the Working Group answered the European Commission's consultation on cultural and creative industries and published a good practice guide showcasing initiatives from 16 cities to foster their creative sector.

(B) Forum Priorities for 2011:

Priorities for 2011:

- Dealing with budget cuts (not only in the UK). Members need to exchange knowledge on how cities cope with the economic downturn, ie. working with the business sector, with volunteers, new partnerships...planning to develop an on-line survey to collect information from cities which will be shared. That will be one of the main topics for discussion during the March Forum meeting in Turku (16-19)
- Culture in the social development of cities including economic and social impacts of culture
- Participation of citizens in local cultural life Focus on children and young people

Contribution to the European policy processes

Early in 2011 the Culture Forum will respond the European Commission's consultation on the future of the European Capital of Culture initiative (after 2019). 26 EUROCITIES members have been designated European Capitals of Culture since 1986 and many more have or are currently biding for the title. EUROCITIES supports the initiative and will propose concrete measures to improve it.

2011 is an important year for the future of the Culture programme. The Commission is currently analysing stakeholders' response to the 2010 consultation on the future of the programme and will come up with a concrete proposal early summer.

2011 will also mark the presentation by the European Commission of new policy actions aimed at supporting the cultural and creative industries. This will be a follow-up of the large consultation launched in 2010.

For both the Culture programme and new actions targeting the creative industries the Culture Forum will follow legislative development and will make sure cities' interests are taken into account by the relevant European institutions.

Cooperation with other EUROCITIES Forums

In 2011 the culture Forum will continue contributing actively to the general EUROCITIES policy development and will input to key dossiers such as the budget review, the future of the European cohesion policy and the European innovation policy.

The Culture Forum will cooperate with the Social Affairs Forum as part of the Autumn Forum in Antwerp that will focus on young people.

Forum activities on cultural and creative industries will also benefit from the input of the EUROCITIES Economic Development Forum (ie Working Group entrepreneurship).

A new Working Group on mobility of artists' and cultural professionals will be launched early 2011

Creative Industries Working Group is now focusing on how cities help developing new creative businesses. It will also meet in May in Nantes on the topic 'creative industries and sustainable development'. The Council's Creative Industries Officer engages in this virtually and will continue to do so.

(C) Areas of Work to be Undertaken with Departmental Director approval in 2011:

Attendance at three forum meetings in 2011 - the first will be in Turku in March and will focus on culture and well-being and a plenary session on new funding schemes for culture (cities facing budget cuts); the second in Aarhus in June focusing on governance for local cultural policies and the cultural production centre of the future; and the third in Antwerp in October - focus on young people and culture and the role of city museums.

The European Culture Forum Conference will be held in Brussels in September 2011.

BCC will contribute to the European policy process through participation in relevant consultations. A watching brief in relation to the development of cultural policy will be maintained and expertise will be shared.

BCC will use the Culture Forum to identify best practice and benchmarking to assist in the delivery of the new Integrated Tourism Strategy and the development of the new Integrated Cultural Plan. The areas to be included in learning, benchmarking and sharing knowledge include cultural infrastructure, use of new technology, heritage issues, development of Belfast Story, maximising Titanic and maritime heritage particularly for 2012, extending benefits of tourism across the city and opportunities through the European Year of Volunteering 2011.

BCC will identify funding opportunities due to open later in 2011 through the Culture Programme and any other funding calls to support corporate plan objectives and in particular tourism, culture and arts.

Creative Industries working group – the Creative Industries Officer engages virtually with this group and will continue to do so.

(D) Expected Results:

To be confirmed – the optimum would be funding to support corporate plan objectives, policy influencing and awareness and creating profile for Belfast internationally.

3. Objectives of the WG	For artists, mobility is a professional and artistic necessity in order to export their work, perform, learn, create, cooperate and discover new ways of expression. An informal group was launched in 2010 in order to explore new ways of funding mobility, new tools and experimental approaches to foster artists' mobility in Europe. This group met during 'Open space' at Forum meetings and a meeting also took place in September 2010 in Brussels for cities interested in fostering mobility and professional cultural networks involved in mobility to meet and share experiences.
4. Actions and expected outputs in 2011	 Setting up a EUROCITIES Working Group will formalize the Open space group on mobility and will set up a frame in order to develop actions to foster mobility of artists and cultural professionals. Meetings will be structured in two parts: a specific theme for debate, and then presentations by cities, underlining new and innovative tools fostering mobility.

This Forum links to and supports work in the Development Department and in particular the Community Services Unit, Policy Unit given the development of the Poverty Framework; and the Economic Development Unit. In addition links to and supports the work of BCC's Good Relations Unit and links to Belfast in Europe given members have the remit for many areas of work that BCC does not have a remit for.

(A) Outputs and Achievements for 2010:

The golden thread running through much of the SAF's work throughout 2010 and which a lot of energy has been dedicated to has been leading the **EUROCITIES Campaign to mark the European Year on Combating Poverty and Social Exclusion**. This has included:

- Thematic seminars discussing long-term unemployment (Katowice), health inequalities (Ghent), child poverty (Newcastle) and areabased approaches to social inclusion (Budapest). Preparatory work for these seminars was undertaken by WG Social Inclusion, WG Employment and WG Health and Wellbeing. Belfast City Council
- Other EUROCITIES Forums contributing to the Campaign in their meetings (environment, culture, digital exclusion, mobility)
- Developing recommendations on combating poverty addressing the European institutions, the Social Protection Committee and the Belgian Presidency.

Two Social Affairs Forum meetings were also held this year:

- March 2010 in Murcia. Theme: Adapting social services to reach the hardest-to-reach groups
- October 2010 in Brussels (joint meeting with the EDF): Final conference of EUROCITIES Campaign to mark the 2011 European Year of Combating Poverty & Social Exclusion. Included presenting the EUROCITIES recommendations to representatives from the EU institutions
 - The EUROCITIES **Network of Local Authority Observatories on active inclusion (NLAO)** was enlarged to ten cities. The NLAO undertakes research and awareness raising on EU active inclusion strategy at the local level.
- Further work has been undertaken towards a shared vision for migrant integration in European cities led by WG Migration and Integration
 - Integrating Cities IV in London launches new Integrating Cities Charter (21 cities signed so far)
 - new project MIXITIES on delivering on Charter commitments
 - The "Inclusive Cities for Europe" PROGRESS partnership with the European Commission has helped support much of this work. The partnership aims to develop a stronger role of cities in EU social inclusion and will continue in 2011-13.
 - Talks have begun with the European Foundation about how EUROCITIES can co-operate with them on Roma inclusion and related matters. This follows on from the work of the WG Social Inclusion earlier in 2010 on the Roma.
 - SAF has also been active in developing a number of publications and contributing to relevant EU policy debates:

- A local perspective on Active Inclusion NLAO-Report "Social Services supporting Active Inclusion **Housing** and **Employment** in five European cities".
- EUROCITIES Response to European Commission on new agenda for migrants integration
- EUROCITIES Message to the Social Protection Committee on mainstreaming migration in social policies
- Key conclusions from EUROCITIES campaign on combating poverty and social exclusion
- EUROCITIES statement on new "Platform Against Poverty"
- EUROCITIES delegation meets Commissioner Cecilia Malmström (Home Affairs) on strengthening cooperation on migrant integration
- EUROCITIES delegation meets Chair of the European Parliament's LIBE Committee Juan Fernando Lopez Aguilar to discuss cooperation

The successful delivery of this programme has been due in no small part to the leadership of the Chair city of Stockholm throughout 2010 represented by Ulf Kristersson and Anna Mattson – as well as the work of the EUROCITIES Social Affairs team and the Steering Group of the Social Affairs Forum which has taken steps to consolidate and strengthen its role throughout 2010; this will be continued and where possible supported by PROGRESS in 2011 to ensure that all facets of the SAF's work are as joined up as possible.

The work illustrated above has informed and contributed to:

- Belfast City Council's Strategic Poverty Framework particularly the learning from the 4 workshops as part of the European Year of Combating Poverty and Social Exclusion.
- Informing the work with the travelling community and inclusion policy for travelling and work ??? Roma
- Receiving up to date information on EU policy and take part in a range of consultations as the arise
- Create awareness of funding developments to support work and to consider partnering opportunities
- Network to learn from the experiences of others and to exchange experience
- Develop relationships with others to create a contacts base for the development of potential future projects
- Profile the work of Belfast
- Take part in debates, surveys and stakeholder groups to influence policy and to feedback on implementation

(B) Forum Priorities for 2011:

The Work Programme reflects the priorities of the new Chair city of the Social Affairs Forum (SAF), Birmingham. After almost two years as Vice Chair, the City of Birmingham was elected SAF Chair on 11 October 2010. The Hague was elected as the SAF's new Vice-Chair.

The vision for the Social Affairs Forum in 2011 is to position the Forum both to support cities to meet the local social challenges they are facing with regard to having to do more with less and helping their citizens through the economic downturn and recovery - and to make the most of the significant 'window of opportunity' the SAF has to influence future EU policy particularly with regard to EU2020 inclusive growth and the future of EU funding for social policy.

EU 2020

This overarching 10 year growth strategy for Europe puts forward three mutually reinforcing priorities:

- Smart growth: developing an economy based on knowledge and innovation.
- Sustainable growth: promoting a more resource efficient, greener and more competitive economy.
- Inclusive growth: fostering a high-employment economy delivering social and territorial cohesion.

The inclusive growth aspects to the strategy are of particular relevance to the SAF. The Commission's proposal defines several **'headline targets'** to be adapted at national level in order to reflect "differing starting points". Three of these relate to social affairs:

- Raising the **employment rate** of the population aged 20-64 from the current 69% to 75%.
- Reducing the share of **early school leavers** from the current 15% to under 10% and making sure that at least 40% of young people have a degree or diploma.
- Reducing the number of Europeans living below the **poverty** line by 25%, lifting 20 million out of poverty from the current 80 million.

The EU2020 Strategy also proposes a number of 'flagship initiatives' a number of which relate to social affairs:

- "Youth on the move" aims to enhance the performance of education systems and to reinforce the international attractiveness of Europe's higher education.
- "An agenda for new skills and jobs" aims to modernise labour markets by facilitating labour mobility and the development of skills throughout the lifecycle with a view to increase labour participation and better match labour supply and demand.
- The "European platform against poverty" aims to ensure social and territorial cohesion such that the benefits of growth and jobs are widely shared and people experiencing poverty and social exclusion are enabled to live in dignity and take an active part in society.

The Social Affairs Forum will work to ensure the views of cities are heard as the EU2020 flagship initiatives are developed further in the coming months.

Given the local and EU policy context outlined above, the priorities for the Social Affairs Forum in 2011 will be:

- Social services in the context of reduced public finances including the future of ESF
- Adapting social services to meet new and emerging social needs
- Tackling economic exclusion through innovative policies for education, unemployment, re-skilling, and combating poverty (including linking to EU2020 inclusive growth proposals)

In addition, for 2011 the **SAF** will also have a social inclusion and combating poverty 'champion' to ensure that this remains high on the agenda for the SAF; it is proposed that the former Chair of the WG Social Inclusion, Newcastle, undertakes this role given the city's key role both in the former Working Group and also in being one of the lead cities throughout the Campaign. This is a new approach which the SAF will adopt throughout 2011. The reasons for this approach are that:

- The decision was taken to close down the WG Social Inclusion not because the issue is not important for cities and at EU level (on the contrary, it is) but in part because a "Working Group" was perhaps not a suitable structure to look at a cross-cutting issue such as Social Inclusion. Social inclusion is a cross-cutting theme all WGs and projects within SAF will be addressing in 2011, the champion role will be to work with the Steering Group to ensure that this is indeed mainstreamed rather than becoming 'lost' as an issue.
- The need to ensure that the EUROCITIES messages and legacy of the Campaign to mark the 2010 European Year of Combating Poverty and Social Exclusion lives on and is capitalised upon throughout 2011.
- In recognition of the fact that inclusion remains high on the agenda for cities, EUROCITIES (one of the network's three overarching priorities is inclusion) and for the EU (the EU 2020 inclusive growth pillar including a Platform on Combating Poverty).

Forum Working Groups for 2011:

Given the priorities for the SAF and also the policy drivers coming from EU level, The proposals for which areas of work will operate under the auspices of the SAF in 2011, as well as the decisions about which ones should receive support, take into account the following elements:

- Linkages to the SAF 2011 priorities
- Opportunity to influence at EU level
- Opportunity to work towards tangible outcomes in 2011
- Level of current active involvement and engagement within existing Working Groups
- Resources available (staff and financial)

Working groups for 2011 are:

- Education
- Migration & Integration

- Employment
- Health and Wellbeing
- Roma & related inclusion issues

(C) Areas of Work to be Undertaken with Departmental Director approval in 2011:

A watching brief on the Education working group for which BCC does not have a direct remit, however, through the Belfast in Europe network and other linkages, relevant policy and funding opportunities will be shared and in particular if that work touches on any of BCC work in particular in the cross cutting area of combating poverty and social exclusion. A watching brief will also be kept on work relating to social services in the context of reduced public finances including the future of ESF and adapting social services to meet new and emerging social needs – this will be shared through the Belfast in Europe network.

Attendance at two full SAF meetings – one to be held in the spring (Grenoble), one to be held in the autumn (Warsaw, jointly with the EDF). The theme of each is to be agreed between EUROCITIES, the SAF Chair and host city and will complement SAF 2011 priorities.

Engagement with the Employment working group for 1 year initially with the Economic Development Unit. Strong partners in the working group, look at social inclusion and employment and social innovation and social enterprise - looking for new ways of doing things through best practice and ideas. Attendance at one Employment working group meeting as part of the SAF meeting in Grenoble.

Engagement in the Migration and Integration working group with Good Relations on the implementation of the Integrating Cities Charter through the MIXITIES project. Council has approved the signing of the Charter and Hazel Francey will arrange that with the Lord Mayor in the coming weeks.

Keep a watching brief on the work of the Roma working group and share information with colleagues in Environmental Services who work on issues as part of a safety group. BCC has no direct remit for Roma at this time.

Engagement in the wider work through the Social Affairs Forum on social inclusion and youth with Community Services – bearing in mind that economic activity is not the only tool to be used in moving out of poverty.

Work with all relevant departments and units and in particular with Community Services, Tourism, Culture and Arts and Events on relevant projects or profiling work in Belfast linked to the European Year of Volunteering 2011.

(D) Expected Results:

To be confirmed – the optimum would be funding to support corporate plan objectives, policy influencing and awareness and creating profile for Belfast internationally.

Actions for 2011

1. Fit-4-Work

The 4 major cities (G4) in the Netherlands (Amsterdam, Rotterdam, The Hague and Utrecht) are developing a new (experimental) Fit-4-Work program for unemployed persons with mental health problems. This experimental program consists of a structured diagnosis and treatment of psychiatric problems, integrated in reintegration with individual placement to work.

Actions

Chair WGE will ask WGE members to be involved in validation of this G4's new ESF project 'Fit-4-Work' Chair WGE will organise 2 expert meetings in Rotterdam in May/June 2011 and September 2011 (funded by Rotterdam).

2. Review ESF/PROGRESS

The European Commission asked EUROCITIES to play an important role in the review of the current ESF Program, in order to contribute to future ESF 2014 -2020 program and PROGRESS. The basic idea is to make an inventory on the usage of ESF/PROGRESS and necessary/desired future adjustments, based on 'working-floor' information and experiences. SAF has asked Chair WGE to pay a leading role in this action. Chair WGRE will develop a format for this. This action will be financed by EUROCITIES.

Actions

Chair WGE will develop a specific plan for this in accordance with Steering Group SAF for meeting in March 2011.

Chair WGE will ask WGE members to be involved Review ESF/PROGRESS and will visit WGE-members in April – June 2011for making an inventory and reporting to SAF in July 2011.

Chair WGE will organise 2 expert-meetings in Autumn 2011for finalizing report with recommendations.

3. SSH-research project on measures for combating poverty and creating employment opportunities

Socio-economic sciences and the humanities (SSH) is the fourth consecutive program of the European Commission on socio-economic sciences and humanities since 1994. In the current program, which is part of the Seventh European Research Framework program emphasis is given to the following areas (a.o.):

- 1-Growth, employment and competitiveness in a knowledge society:
 - innovation, competitiveness and labour market policies;
 - education and life-long learning;
 - economic structures and productivity.
- 2-Combining economic, social and environmental objectives in a European perspective:
 - models within Europe and across the world;
 - economic and social and cohesion across regions;
 - social and economic dimensions of environmental policy.
- 3-Major trends in society and their implications demographic change, reconciling family and work, health and quality of life, youth policies, social exclusion and discrimination.
- 4-Socio-economic and scientific indicators the use and value of indicators in policymaking at macro and micro levels.
- 5 -Foresight activities the future implications of global knowledge, migration, ageing, risk and the emerging domains in research and science.
- 6 -Strategic activities including research for policy support and international cooperation

Chair WGE has offered a consortium of Universities to participate in study/survey for EC in the frame of SSH-research project on measures for combating poverty and creating employment opportunities. This study/survey will be funded and executed by SSH-consortium universities and provide contributing cities important information for measures for combating poverty and creating employment opportunities, based

on a scientific comparison.

Actions

Chair WGE will develop a specific plan for this in accordance with SSH Consortium of Universities in January – February 2011.

Chair WGE will ask WGE members to be involved in SSH-project (March 2011)

4. Monitoring / input EC flagship initiative agenda for New Skills/New jobs

Research shows that new and higher levels of skills will be needed for the jobs of tomorrow. The economic crisis and structural factors like globalisation, technological changes, ageing populations and the shift to a low-carbon economy are all contributing to rapid change in European labour markets.

As a result of this fast moving evolution, shortages of adequate skills in some sectors or occupations already co-exist with unemployment across the EU.

To provide job opportunities for all and create a more competitive and sustainable economy, Europe needs a highly skilled workforce able to meet current and future challenges. To ensure this, it is urgent to invest in the right skills and improve matching of jobs with these skills in the EU, by effectively anticipating future trends.

A joint policy initiative carried out in cooperation between the European Commission and the EU Member States, New Skills for New Jobs aims to address some of these issues by supporting EU countries and regions in developing more effective ways to analyse and predict which skills will be required in tomorrow's labour markets and, with this knowledge, developing and adapting education and training so that the workers gain the skills required.

Actions

Chair WGE will develop a specific plan for contribution to New Skills/New jobs initiative with Brussels in February 2011.

Chair WGE will organise expert-meeting in 2011, simultaneous with SAF-meeting.

5. Chair

Rotterdam agreed to chair the WGE in 2010 and 2011 and will undertake the necessary actions for establishing relationships with cities that want to participate in the WGE.

The WGE has expressed a special interest in the participation of southern or eastern European cities.

Rotterdam will also conduct a partner-search in 2011 for a co-chair and future chair, if possible also from a southern or eastern European city. Rotterdam will report the findings in the meetings of WGE.

- Likewise at a city level, learning and building stronger links with Roma communities and agencies is vital.
- There is a definite role for the development of rights and legislation based pressure on countries improve their position on Roma
- We need to understand more about the drivers for migration between particular states.
- We need to learn more about the diversity of Roma and their situations.
- The attitude, understanding and skills of staff working with Roma is vitally important.
- How to we deal with the "catch 22" of a countries or a city being welcoming to Roma and then being faced with more migration than they can cope with?

What should the balance of European strategy be? Improving the situation in countries of origin in East Europe or improving the situation in receiving countries in West Europe?
