## Section 1: Introduction and Background

- 1.1 The Connswater Community Greenway offers one of the most ambitious and positive developments within East Belfast and Belfast for many years and the opportunity to change the landscape and quality of life experience for many of the community who live, work and play within the Connswater catchment area.
- 1.2 Supported by the Big Lottery, and statutory investment, and directed and guided by a formal partnership structure, recognising the role of the Belfast City Council, the community and statutory partners, implementation is driven by a dedicated team. Moving from concept stage to implementation the development is currently being rolled out with major milestones such as the Thompson bridge and CS Lewis festival and small developments such as the Avoniel allotments illustrating success and progress on the ground.
- 1.3 At this stage the reality of the Greenway and how it might impact upon neighbourhoods and communities is coming to the fore. Identifying and providing solutions to any perceived issues that may arise such as access, lighting, environmental impact and safety is a priority. A key challenge is balancing such concerns with a commitment to develop and maintaining the "spine" of the Greenway as open, accessible, well lit, creating a gateway and resource to all citizens.
- 1.4 Meaningful community engagement has been one of the principles of the Greenway from its initiation, pre-planning to the current development stage. From the initial community consultation, through the current work of the engagement officer and the activities of the Connswater Engagement group, there has been an ongoing proactive effort made to seek and respond to concerns real and perceived as well as communicating the good news.
- 1.5 As part of the ongoing process the Project Delivery Board agreed the need to undertake a robust stakeholder and community engagement process "...to determine local considerations, community perceptions and stakeholder views on the following elements along the main spine and throughout general areas of the CCG:
  - Lighting (24 hours a day)
  - Opening/ closing of parks (24 hours a day)
  - Health and safety risks
  - Antisocial behaviour (ASB)
  - Environmental restrictions and improvements
- 1.6 To support the process the BCC Council on behalf of the Project Board developed a comprehensive Terms of Reference and through a competitive tendering process commissioned Blueprint Development Consultancy in association with Social Market Research to undertake this assignment. Appointed in January 2014 the Team, through discussions agreed an approach and methodology set out below.
- 1.7 This draft report is presented as follows: section 2 sets out the agreed approach and methodology; section 3 sets out the results and analysis of the primary research; section 4 provides a summary of the qualitative research based on stakeholder consultation; section 5 summarises the key issues arising and possible solutions; and, section 6 offers some conclusions to be considered by the Project Board and Council.

## **Section 2: Methodology**

## 2.1 Agreed Approach

Through discussion with the Council lead officer and the project Board an outline approach was agreed as summarised below;

## 2.2 Using Scenarios

Given the nature of the assignment and the volume of engagement activity which has been undertaken over a prolonged period by the CCG Team, the agreed focus of the consultation process was to seek additional views and comments relating to scenarios which may arise with a focus on identifying any practical solutions. The proposed strands of the work included the following:

- Consultation with the following groupings<sup>1</sup>:
  - ✓ Political: Individual and group discussions with BCC and Castlereagh Local Councillors;
  - ✓ Funding and Statutory Agencies: The CCG Board ,BCC, PSNI, DOE, Rivers Agency, The BIG Lottery Fund, DSD, DARD;
  - ✓ Stakeholder Groups: EBCDA, EBP, Inner East Outer East NRP, OASIS ,Charter NI;
  - ✓ Community Groups, Resident Associations and specific Interest groups: Sporting, Parks, Leisure, Churches, Active Age Groups, Youth Groups, and Schools: Private sector, Community safety partnerships.
- Utilising the Local Press: Short articles in local press utilising the CCG brand seeking views and comments
- Utilising Social Media: Linking into the CCG site, to elicit views through, email, facebook and twitter if appropriate. This was combined with an online survey facilitating cross-tabulation by gender, age, religious background, area etc;
- A Household survey: Providing households living in close proximity to the CCG with the opportunity to take part in the consultation was considered critical to the overall success of this stakeholder engagement exercise. Consulting with households also provides the CCG with an opportunity to further develop and sustain a positive relationship with the community ensuring that their views valued and considered as part of the overall development process. The option selected was for a Household survey conducted by social survey interviewers (n=300). The survey was conducted using quotas for age, sex, social class and area and conducted as a standard market research household survey. This provided for a 10 minute interview on a sample of 300 households drawn from all electoral wards making up the area affected by the CCG. The questionnaire included a range of open and closed questions with all data analysed and reported on in line with standard practice. Note that the household survey was supplemented with an online survey of stakeholders.

## 2.3 Comprehensive Consultation

The above methods provided an opportunity to seek additional views and comments over a relatively short period of time .The following sections provide a summary of the key findings and issues arising.



## **Section 3: Primary Research**

#### 3.1 Introduction

An important element of the consultation was to quantify the views of residents and other stakeholders living in close proximity to the Greenway. To realise this objective it was agreed with BCC that we would conduct the following:

- A survey among a representative sample of residents aged 16+ living in areas surrounding the Greenway; and,
- Provide a version of the survey questionnaire online to allow other stakeholders the opportunity to express their views on the consultation.

### 3.1.1 Resident Survey

The core survey is based on face-to-face interviews with 300 residents living in areas surrounding the Greenway. Respondents were selected on the basis of tightly controlled quotas for respondent: age, gender, social class and area (see Appendix 4 for a list of streets included in the survey). In close consultation with BCC a questionnaire was developed and agreed (see Appendix 2). The view of CCG was also sought on questionnaire design and content. Following agreement of the questionnaire fieldwork was conducted between 21 and 31 March 2014. Table 3.1 presents a profile of respondents in the main resident survey.

## 3.1.2 Online Survey

It was agreed with BCC to make the survey questionnaire available online to other stakeholders. With the support of CCG the survey link was emailed to their stakeholder database. A total of 142 stakeholders completed the survey online. Table 3.1 also presents an overview of the profile of stakeholders.

### 3.1.3 Differences in the Sample Profile between the Resident and Online Surveys

In conducting the main resident survey, the key objective was to produce a sample which is representative of the resident population living in the areas around the Greenway, with quota controls for key characteristics (e.g. age and gender etc) based on census estimates. However the online survey link was forwarded only to those listed on the CCG stakeholder database.

A review of Table 3.1 shows that there are key differences on some characteristics between both samples. For example, there are proportionately more males in the online stakeholder sample (59%) compared with the main resident survey (48%), with the online sample having a greater proportion of respondents from social classes ABC1 (80% vs. 46%) as well as a greater proportion of respondents educated to degree level of equivalent (67% vs. 11%). Given these differences our key focus is on presenting the findings for the representative survey of residents. However, we also comment on the findings from the online survey (note that in many instances the results from both surveys are consistent).

#### 3.1.4 Notes on Tables

Due to rounding row and column totals within tables may not always sum to 100. Note that base totals may also change in tables depending on question routing. It should be noted that dash marks [-] are used in some tables to indicate that the figure is less than 1%.

## 3.1.5 Data Analysis and Statistical Significance

All data were analysed using SPSS, with statistical differences identified using appropriate statistical tests. Throughout the results section of this report statistical significance is reported at the level of significance: p<=0.05 equates to the 95% confidence interval; p<=0.01 equates to the 99% confidence interval; and, p<=0.001 equates to the 99.9% confidence level.


## 3.2 Awareness of the Connswater Community Greenway

## 3.2.1 Awareness of the Greenway (Resident Survey)

Respondents were asked if they were aware of the Connswater Community Greenway (CCG). To support this question, respondents were shown a map of the CCG and presented with the following information:

'The Connswater Community Greenway / East Belfast Flood Alleviation Scheme is a 9km linear park through East Belfast. It follows the course of the Connswater, Knock and Loop Rivers, connecting open and green spaces and revitalising the neglected Connswater River system'.

Almost three guarters (73%) of residents had heard of the Connswater Community Greenway.



There were a number of statistically significant differences in response:

- Older residents (aged 60+, 62%) were less likely to be aware of the CCG (16-29, 73%; 30-59, 79%, p<=0.05),
- Married residents (84%) were more likely to be aware of the CCG compared with others (single, 64%: separated, widowed or divorced, 58%, p<=0.001);</li>
- Residents in social classes ABC1 (80%) were more likely to be aware of the CCG compared with residents in social classes C2DE (67%, p<=0.01);</li>
- Residents living right beside the CCG or a few streets away (79%) were more likely to be aware of it compared with residents living a quarter of a mile or more from it (67%, p<=0.05); and,</li>
- Residents with a limiting long-term illness (53% vs. 78%, p<=0.001)were less likely to be aware of the CCG.


## 3.2.2 Awareness of the Greenway (Online Stakeholder Survey)

Among stakeholders who participated in the online survey, 94% were aware of the Connswater Community Greenway.

### 3.2.3 Source of Awareness of the Greenway (Residents Survey)

Among residents who were aware of the CCG, 36% had found out about it through 'word of mouth', with 32% citing a local talk, 15% newspapers, and 11% leaflets.

## 3.2.4 Source of Awareness of the Greenway (Online Stakeholder Survey)

In the online survey, stakeholders listed a range of sources of their awareness of the Greenway and these are listed on a verbatim basis in Table 1 in Appendix 3.

## 3.2.5 Residents Being Kept Informed about the Greenway (Resident Survey)

All respondents were asked to say how well informed they are about the Greenway, with 34% saying they felt 'very well informed' or 'well informed'. Two out of three residents (66%) felt they are 'not very well' or 'not at all well informed' about the Greenway.

There were a number of statistically significant differences in response:

- Residents in social classes ABC1 (41%) were more likely to say there are well informed about the Greenway (C2DE, 28%, p<=0.05);</li>
- Residents with a limiting long-term illness (19% vs. 38%, p<=0.01) were less likely to say there are well informed about the Greenway;
- Residents with lower levels of educational attainment<sup>2</sup> were less likely to say there are well informed about the Greenway (high, 42%; medium, 41%; low, 22%, p<=0.01);</li>
- Residents living beside or within a few streets of the Greenway (29%) were less likely to say there are well informed about the Greenway compared with residents living further away (40%, p<=0.05);</li>

## 3.2.6 Stakeholders Being Kept Informed about the Greenway (Online Stakeholder Survey)


Among stakeholders in the online survey, 75% said they felt 'very well informed' or 'well informed' about the Greenway. Twenty five percent (25%) felt they are 'not very well' or 'not at all well informed' about the Greenway.

#### 3.2.7 Residents Being Kept Informed about the Greenway in the Future (Resident Survey)

Among residents, 58% said they would like to be kept informed about future developments relating to the Greenway.

There were a number of statistically significant differences in response:

- Older residents (aged 60+, 47%) were less likely to say they wanted to be kept informed about future developments relating to the Greenway (16-29, 56%; 30-59, 64%, p<=0.05);
- Residents with a limiting long-term illness (37% vs. 63%, p<=0.001) were less likely to want to be kept informed about future developments relating to the Greenway;</li>
- Residents with lower levels of educational attainment were less likely to say they want to be kept informed about future developments relating to the Greenway (high, 63%; medium, 66%; low, 47%, p<=0.05), and,
- Current users of the Greenway (64% vs. 53%, p<=0.05) were more likely to want to be kept informed about future developments relating to the Greenway.

## 3.2.8 Stakeholders Being Kept Informed about the Greenway in the Future (Online Stakeholder Survey)

The overwhelming majority (91%) of stakeholders in the online survey said they want to be kept informed about future developments relating to the Greenway.

## 3.2.9 Residents Preferred Way to Being Kept Informed about the Greenway in the Future (Resident Survey)

Among respondents (n=174) who said they want to be kept informed about Greenway, 51% said they preferred to be kept informed via a leaflet, with 37% citing newspapers and 13% TV.




Figure 5: Moving forward, what is the best method for keeping you informed about the Connswater Community Greenway? (Base=174)

## 3.2.10 Stakeholders Preferred Way to Being Kept Informed about the Greenway in the Future (Online Stakeholder Survey)

The online survey respondents suggested a number of ways of being kept informed and these are presented in Table 2 in Appendix 3.

#### 3.2.11 Single Most Important Thing to be Kept Informed about (Resident Survey)

Respondents in the resident's survey who wanted to be kept informed about the Greenway were asked to identify the single most important thing they wanted to be kept informed about. Their responses are listed in Table 1 in Appendix 2.

### 3.2.12 Single Most Important Thing to be Kept Informed about (Online Stakeholder Survey)

Stakeholders in the online survey who wanted to be kept informed about the Greenway were asked to identify the single most important thing they wanted to be kept informed about. Their responses are listed in Table 3 in Appendix 3.

## 3.2.13 Resident Interest in the CCG (Resident Survey)

Among all respondents in the resident's survey, 68% said they are either 'very interested' or 'interested' in the Connswater Community Greenway, with 32% saying they are 'not very interested' or 'not at all interested' in the Greenway.

There were a number of statistically significant differences in response:

- Older residents (aged 60+, 50%) recorded a lower level of interest in the Greenway compared with other age groups (16-29, 67%: 30-59, 78%, p<=0.001);
- Residents in social classes ABC1 (77%) expressed a higher level of interest (C2DE, 61%, p<=0.01);</li>
- Residents with a limiting long-term illness (46% vs. 73%, p<=0.001) expressed a lower level of interest; and,
- Residents with a lower level of educational attainment expressed a lower level of interest in the Greenway (high, 73%; medium, 80%; low, 53%, p<=0.001);</li>

### 3.2.14 Stakeholder Interest in the CCG (Online Stakeholder Survey)

Almost all (97%) stakeholders in the online survey said they are very interested (59%) or interested (38%) in the Greenway.


## 3.3 Benefits of the Greenway

## 3.3.1 Resident Awareness of the Benefits of the Greenway (Resident Survey)

In developing the Connswater Community Greenway it was anticipated that there would be a range of benefits for the local community. Respondents were presented with a list of different uses of the Greenway and asked if they seen each as a benefit for the local community.

Figure 7 shows that the overwhelming majority of residents seen all the possible uses of the Greenway as either a major or minor benefit to the local community.

Figure 7: Thinking about each of the following uses of the Greenway, please say if you see each as a benefit, or not, to the local community. (Base=300)



Approximately seven out of ten (72%) residents identified improving the quality of life for people in the community as a major benefit, with the same number identifying the following as major benefits: improving the environment in the local area; and, using the Greenway for walking.

Other benefits cited by a small number (n=10) of residents included: bowling green; good for expressing our community; flood relief; getting people outdoors / active; jobs; keeps my house private at the back; more chance to exercise; need to clean up the Connswater river; provides a positive space for the community; and, traffic relief.

## 3.3.2 Stakeholder Awareness of the Benefits of the Greenway (Online Stakeholder Survey)




Figure 8: Thinking about each of the following uses of the Greenway, please say if you see each as a benefit, or not, to the local community. (Base=142)

As with residents, the overwhelming majority of stakeholders in the online survey see all the possible uses of the Greenway as either a major or minor benefit to the local community (Figure 8).

## 3.3.3 Most Important Benefit of the Greenway to the Local Community (Resident Survey)

Having considered different benefits of the Greenway, respondents were asked to identify what they see as being the most important benefit.

Approximately one in five (19%) identified the most important benefit of the Greenway as being an area for families, with 12% citing events and activities as the most important benefit.




Figure 9: Most important benefit of the Greenway to the local community (Base=300)

## 3.3.4 Most Important Benefit of the Greenway to the Local Community (Online Stakeholder Survey)

Among stakeholders in the online survey, 19% identified walking at the most important benefit of the Greenway, with 16% seeing the Greenway as a resource to help improve the health of local people, and 13% seeing the main benefit as being able to use it to get to work.





Figure 10: Most important benefit of the Greenway to the local community (Base=142)

## 3.4 Using the Greenway

## 3.4.1 Resident's Current Use of the CCG (Resident Survey)

Just under half (45%) of residents said they currently use the Greenway.

There were a number of significant differences in response:

- Older residents (aged 60+, 24%) were less likely to be current users of the Greenway (16-29, 55%: 30-59, 50%, p<=0.001);
- Residents with a limiting long-term illness (22% vs. 51%, p<=0.001)were less likely to be current users of the Greenway; and,
- Residents with a lower level of educational attainment were less likely to be current users of the Greenway (high, 54%; medium, 54%; low, 29%, p<=0.001).


## 3.4.2 Stakeholder's Current Use of the CCG (Online Stakeholder Survey)

Approximately three out of four (76%) stakeholders in the online survey indicated that they currently use the Greenway.

### 3.4.3 Resident Likelihood of Using the CCG (Resident Survey)

Almost seven out of ten (69%) residents said they would be either 'very likely' or 'likely' to use the Greenway when it opens, with 21% saying they would be either 'unlikely' or 'very unlikely' to do so. One in ten respondents was undecided.

There were a number of significant differences in response:

- Older residents (aged 60+, 34%) were less likely to say they would use the Greenway in the future (16-29, 80%: 30-59, 80%, p<=0.001);
- Residents in social classes ABC1 (76%) were more likely to say they would use the Greenway in the future (C2DE, 62%, p<=0.01);
- Residents with a limiting long-term illness (31% vs. 78%, p<=0.001) were less likely to say they would use the Greenway in the future;
- Residents with a lower level of educational attainment were less likely to say they would use the Greenway in the future (high, 78%; medium, 87%; low, 44%, p<=0.001);
- Residents living beside or within a few streets of the Greenway (75%) were more likely to say they would use it in the future compared with residents living further from it (62%, p<=0.05); and,
- Current users (97%) of the Greenway were more likely to say they would use it in the future compared with non users (46%, p<=0.001).

Respondents who indicated that they are likely to use the Greenway in the future were asked what they would be likely to use it for. These responses are listed on verbatim basis in Table 2 Appendix 2. Similarly, the reasons why respondents would not use the Greenway in the future are listed in Table 3 Appendix 2.

## 3.4.4 Stakeholder Likelihood of Using the CCG (Online Stakeholder Survey)

Almost all (96%) stakeholders in the online survey indicated that they are either 'very likely' or 'likely' to use the Greenway when it opens.


As was the case in the resident survey, those in the online stakeholder survey were invited to say what they are likely to use the Greenway for in the future. These responses are listed in Table 5 in Appendix 3. The reasons why a small number of stakeholders said they would be unlikely to use the Greenway in the future are listed in Table 6 in Appendix 3.

## 3.5 Views on the Greenway

#### 3.5.1 Resident Attitudes (Resident Survey)

Respondents were presented with a number of statements and asked if they agreed or disagreed with each.

Overall, the highest level of agreement (85%) was recorded for the statement 'If the Greenway is lit 24 hrs a day this will improve people's sense of personal safety', whereas the lowest level of agreement (65%) was recorded for the following statements: 'I would be more likely to use the Greenway if it was lit 24 hrs a day' and 'people in this area have a strong connection with the Greenway'.



There were a number of significant differences in response:

#### STATEMENT: I would be more likely to use the Greenway if it was lit 24 hrs a day

- Older residents (aged 60+, 35%) were less likely to agree with this statement (16-29, 71%: 30-59, 76%, p<=0.001);
- Residents with a limiting long-term illness (32% vs. 73%, p<=0.001) were less likely to agree with this statement;
- Residents with a lower level of educational attainment were less likely to agree with this statement (high, 71%; medium, 77%; low, 47%, p<=0.001);
- Residents living beside or within a few streets of the Greenway (73%) were more likely to agree with this statement compared with residents living further from it (56%, p<=0.01); and,</li>
- Current users (81%) of the Greenway were more likely to agree with this statement compared with non users (52%, p<=0.001).

## STATEMENT: If the Greenway is lit 24 hrs a day this will improve people's sense of personal safety

- Residents in social classes ABC1 (91%) were more likely to agree with this statement (C2DE, 81%, p<=0.05);
- Residents with a lower level of educational attainment were less likely to agree with this statement (high, 88%; medium, 94%; low, 77%, p<=0.05);
- Residents living beside or within a few streets of the Greenway (94%) were more likely to agree with this statement compared with residents living further from it (77%, p<=0.001); and,
- Current users (93%) of the Greenway were less likely to agree with this statement compared with non users (79%, p<=0.01).

#### STATEMENT: Opening the Greenway 24 hours a day will help promote positive use

- Residents with a limiting long-term illness (53% vs. 76%, p<=0.01) were less likely to agree with this statement;
- Residents with a lower level of educational attainment were less likely to agree with this statement (high, 74%; medium, 81%; low, 61%, p<=0.05);</p>
- Residents who are economically active (72% vs. 50%, p<=0.05) were more likely to agree with this statement;
- Residents living beside or within a few streets of the Greenway (77%) were more likely to agree with this statement compared with residents living further from it (68%, p<=0.05); and,</li>

• Current users (84%) of the Greenway were less likely to agree with this statement compared with non users (62%, p<=0.001).

#### **STATEMENT:** People in this area are proud of the Greenway

- Older residents (aged 60+, 55%) were less likely to agree with this statement (16-29, 64%: 30-59, 76%, p<=0.05);
- Residents with a limiting long-term illness (51% vs. 72%, p<=0.05) were less likely to agree with this statement;
- Residents with a lower level of educational attainment were less likely to agree with this statement (high, 72%; medium, 80%; low, 54%, p<=0.001);
- Protestant (73%) respondents were more likely to agree with this statement compared with Catholic respondents (47%) and respondents who described their community background as 'other' (54%, p<=0.01);
- Residents living beside or within a few streets of the Greenway (73%) were more likely to agree with this statement compared with residents living further from it (62%, p<=0.001); and,</li>
- Current users (86%) of the Greenway were less likely to agree with this statement compared with non users (53%, p<=0.001).

### STATEMENT: People in this area have a strong connection with the Greenway

- Older residents (aged 60+, 53%) were less likely to agree with this statement (16-29, 61%: 30-59, 73%, p<=0.01);
- Residents with a limiting long-term illness (48% vs. 69%, p<=0.01) were less likely to agree with this statement;
- Residents with a lower level of educational attainment were less likely to agree with this statement (high, 69%; medium, 76%; low, 52%, p<=0.01);
- Protestant (70%) respondents were more likely to agree with this statement compared with Catholic respondents (47%) and respondents who described their community background as 'other' (50%, p<=0.01);
- Residents living beside or within a few streets of the Greenway (68%) were more likely to agree with this statement compared with residents living further from it (62%, p<=0.05); and,</li>
- Current users (81%) of the Greenway were more likely to agree with this statement compared with non users (52%, p<=0.001).

#### **STATEMENT:** I am supportive of the Connswater Community Greenway initiative

- Older residents (aged 60+, 54%) were less likely to agree with this statement (16-29, 65%: 30-59, 84%, p<=0.001);
- Residents with a limiting long-term illness (53% vs. 77%, p<=0.001) were less likely to agree with this statement;
- Residents with a lower level of educational attainment were less likely to agree with this statement (high, 76%; medium, 88%; low, 55%, p<=0.001);
- Protestant (76%) respondents were more likely to agree with this statement compared with Catholic respondents (53%) and respondents who described their community background as 'other' (61%, p<=0.001);
- Residents living beside or within a few streets of the Greenway (79%) were more likely to agree with this statement compared with residents living further from it (64%, p<=0.001); and,</li>
- Current users (87%) of the Greenway were more likely to agree with this statement compared with non users (59%, p<=0.001).


#### STATEMENT: The Greenway is important to east Belfast

- Older residents (aged 60+, 62%) were less likely to agree with this statement (16-29, 68%: 30-59, 86%, p<=0.001);
- Residents with a limiting long-term illness (59% vs. 80%, p<=0.01) were less likely to agree with this statement;
- Residents with a lower level of educational attainment were less likely to agree with this statement (high, 78%; medium, 88%; low, 63%, p<=0.01);</li>
- Protestant (80%) respondents were more likely to agree with this statement compared with Catholic respondents (53%) and respondents who described their community background as 'other' (65%, p<=0.001);
- Residents living beside or within a few streets of the Greenway (81%) were more likely to agree with this statement (71%, p<=0.05); and,
- Current users (90%) of the Greenway were less likely to agree with this statement (64%, p<=0.001).

## 3.5.2 Stakeholder Attitudes (Online Stakeholder Survey)

Analysis of the attitudes of stakeholders to the Greenway, were found to be overwhelming positive.

Figure 14: Views on the Greenway (Base=142)




## 3.6 Reporting Anti-Social Behaviour

## 3.6.1 Residents and Personal Responsibility to Report Anti-Social Behaviour (Resident Survey)

A majority (69%) of respondents in the resident survey said that if they witnessed anti-social behaviour on any part of the Greenway they have a personal responsibility to report it, with 19% saying they don't feel they have a personal responsibility to report it and 12% answering 'don't know'.

There were a number of significant differences in response:

- Analysis by community background found that Protestant respondents were more likely (72%) to believe that they have a personal responsibility to report anti-social behaviour if they witnessed it on any part of the Greenway (Catholic, 53%: other community background, 61%, p<=0.05);
- Respondents with a lower level of educational attainment were less likely to believe that they have a personal responsibility to report anti-social behaviour if they witnessed it on any part of the Greenway (high, 68%; medium, 77%; low, 62%, p<=0.05); and,
- Residents living beside or within a few streets of the Greenway (77%) were more likely to believe that they have a personal responsibility to report anti-social behaviour if they witnessed it on any part of the Greenway (those living further away from the Greenway, 60%, p<=0.001).

## 3.6.2 Stakeholders and Personal Responsibility to Report Anti-Social Behaviour (Online Stakeholder Survey)

More than eight out of ten (86%) respondents in the stakeholder survey held the view that if they witnessed anti-social behaviour they have a personal responsibility to report it.

## 3.6.3 Residents Reporting Anti-Social Behaviour if Witnessed it (Resident Survey)

Approximately seven out of ten (72%) residents said they would report anti-social behaviour if they witnessed it, with 11% saying they would not, and 16% answered 'don't know'.

There were a number of significant differences in response:

- Respondents with a lower level of educational attainment were less likely to say they would report anti-social behaviour if they witnessed it (high, 76%; medium, 78%; low, 64%, p<=0.01); and,
- Residents living beside or within a few streets of the Greenway (79%) were more likely to say they would report anti-social behaviour if they witnessed it (those living further away from the Greenway, 66%, p<=0.001).

Respondents (n=31) who indicated that they would not report anti-social behaviour were asked to say why, with their reasons listed in Table 3.2.

#### 3.6.4 Stakeholders Reporting Anti-Social Behaviour if Witnessed it (Online Survey)

Three out of four (75%) respondents in the stakeholder survey said they would report antisocial behaviour if they witnessed it.

The reasons why stakeholders would not report anti-social behaviour included: 'I have reported it before, but the police officer told me there was nothing they could do about it' (n=1); 'It needs to be addressed' (n=1); 'Lack of confidence in the relevant authorities' (n=1); 'Police take too long to arrive' (n=1); 'Scared of repercussions or making situation worse' (n=1); 'wouldn't see the point the behaviours already happened so me reporting it wouldn't change what's already happened'.

#### 3.7 Concerns about the new Connswater Community Greenway (Resident Survey)

## **Resident Concerns (Resident Survey)**

Around one in three (35%) respondents in the resident survey said they have concerns about the new Connswater Community Greenway. Older respondents (aged 60+, 46%) were more likely to express concerns compared with respondents in other age groups (16-29, 23%: 30-59, 36%, p<=0.05).

## 3.7.2 Stakeholder Concerns (Online Survey)

Almost half (47%) of stakeholders said they had concerns about the new Connswater Greenway.

## 3.7.3 Resident Specific Concerns (Resident Survey)

The most common concerns expressed by residents were people drinking at night (20%), antisocial behaviour (13%) vandalism / graffiti (11%) and drug use at night (10%).

Other concerns listed by respondents included: floods (n=1); gateway / pathway beside a respondent's house (n=1); maintaining the river (n=1); need for disabled facilities (n=1); cutting down trees (n=1); danger to cyclists and kids (n=1); more bins (n=1); and, lights (n=1).




Figure 18: Specific concerns expressed by respondents (Base=300)


## 3.7.4 Stakeholder Specific Concerns (Online Stakeholder Survey)

# 3.7.5 Residents Witnessing Negative Behaviour or Problems in the CCG Area (Resident Survey)

Overall, 14% of respondents said they had personally witnessed negative behaviours or problems in the Greenway area, with current users of the Greenway more likely to say they have witnessed negative behaviours or problems (20% vs. 9%, p<=0.01).

Respondents who reported witnessing negative behaviours or problems were asked to say which areas they had witnessed this, with these responses included in Table 4 Appendix 2.

The most common negative behaviours or problems witnessed by respondents included: antisocial behaviour (6%), dog fouling (5%) and people drinking at night (3%).

## 3.7.6 Stakeholders Witnessing Negative Behaviour or Problems in the CCG Area (Online Stakeholder Survey)


Almost three out of ten (28%) respondents in the stakeholder survey said they had witnessed negative behaviours or problems in the Greenway area. The areas that stakeholders witnessed negative behaviours or problems are listed in Table 8 in Appendix 3, with the specific negative behaviours or problems listed in Table 9 in Appendix 3.

## 3.8 Support for Initiatives to Support opening of the Greenway

#### 3.8.1 Resident Support for Initiatives among Residents (Resident Survey)

The survey was an opportunity to elicit resident views for a number of proposed initiatives to help support the opening of the Greenway. Figure 20 shows that residents are overwhelmingly supportive of each of the initiatives listed.

Figure 20: Please say how supportive or unsupportive you are of each of the following initiatives. (Base=300)




Approximately one in ten (11%) respondents suggested further initiatives they believe should be put in place before the Greenway opens and these suggestions are included in Table 5 in Appendix 2.

## 3.8.2 Stakeholder Support for Initiatives among Stakeholders (Online Stakeholder Survey)

The vast majority of stakeholders were found to be supportive of the initiatives proposed as part of the opening of the Greenway.

Approximately four out of ten (41%) stakeholders suggested further initiatives they believe should be put in place before the Greenway opens and these suggestions are included in Table 10 in Appendix 3.

## 3.9 Support for Proposals


A key objective of the survey was to assess the level of support for opening the Greenway 24 hours a day and lighting the Greenway after dark.

## 3.9.1 Resident Support for Proposal that CCG is Open 24 Hours a Day (Resident Survey)

Approximately nine out of ten (91%) respondents in the resident survey are either 'very supportive' or 'supportive' of the Greenway being open 24 hours a day, with 10% either 'unsupportive' or 'very unsupportive'.

The level of support for opening the Greenway 24 hours a day was found to be significantly higher among current users of the Greenway (94% vs. 87%, p<=0.05).

Respondents unsupportive (n=31) of the Greenway being open 24 hours a day were given the opportunity to list their concerns around this proposal, and these are presented in Table 6 in Appendix 2. These 31 respondents were also asked if their concerns were addressed would they be supportive of the proposal, with 26% saying they would be supportive, 39% saying they would still be unsupportive of the proposal, and 36% undecided.

## 3.9.2 Stakeholder Support for Proposal that CCG is Open 24 Hours a Day (Online Stakeholder Survey)

Overall 87% of stakeholders are either 'very supportive' or 'supportive' of the Greenway being open 24 hours a day, with 13% either 'unsupportive' or 'very unsupportive'.


Stakeholders unsupportive (n=18) of the Greenway being open 24 hours a day were given the opportunity to list their concerns around this proposal, and these are presented in Table 11 in Appendix 3. These 18 respondents were also asked if their concerns were addressed would they be supportive of the proposal, with 28% (n=5) saying they would be supportive, 28% (n=5) saying they would still be unsupportive of the proposal, and 44% (n=8) undecided.

## 3.9.3 Resident Support for Having the CCG Lit 24 Hours a Day (Resident Survey)

More than nine out of ten (94%) survey respondents are supportive of the main spine and general areas of the Greenway being lit 24 hours a day, with 6% unsupportive.

Respondents living beside or a few streets from the Greenway recorded a significantly higher level of support (97%) for this proposal compared with those living further from the Greenway (90%, p<=0.05).

Respondents unsupportive (n=18) of the Greenway being lit 24 hours a day were given the opportunity to list their concerns around this proposal, and these are presented in Table 7 in Appendix 2. These 18 respondents were also asked if their concerns were addressed would they be supportive of the proposal, with 11% saying they would be supportive, 56% saying they would still be unsupportive of the proposal and 33% undecided.

## 3.9.4 Stakeholder Support for Having the CCG Lit 24 Hours a Day (Online Stakeholder Survey)

More than nine out of ten (94%) stakeholders are supportive of the main spine and general areas of the Greenway being lit 24 hours a day, with 6% unsupportive.


Stakeholders unsupportive (n=9) of the Greenway being lit 24 hours a day were given the opportunity to list their concerns around this proposal, and these are presented in Table 12 in Appendix 3. These 9 respondents were also asked if their concerns were addressed would they be supportive of the proposal, with 22% (n=2) saying they would be supportive, 56% (n=5) saying they would still be unsupportive of the proposal and 22% (n=2) undecided.

## 3.9.5 Resident Support for Having the CCG Open and Lit 24 Hours a Day (Resident Survey)

Overall 94% of respondents are supportive of the proposal for the Greenway to be open 24 hours a day with 24 hour lighting along the main spine and throughout general areas of the Greenway, with 6% unsupportive.

Respondents living beside or a few streets from the Greenway recorded a significantly higher level of support (96%) for this proposal compared with those living further from the Greenway (90%, p<=0.05).

Respondents unsupportive of the Greenway being open 24 hours and lit 24 hours a day were given the opportunity to list their concerns around this proposal, and these are presented in Table 8 in Appendix 2. These 20 respondents were also asked if their concerns were addressed would they be supportive of the proposal, with 68% saying they would not be supportive and 32% undecided.

## 3.9.6 Stakeholder Support for Having the CCG Open and Lit 24 Hours a Day (Online Stakeholder Survey)

Overall 88% of stakeholders are supportive of the proposal for the Greenway to be open 24 hours a day with 24 hour lighting along the main spine and throughout general areas of the Greenway, with 12% unsupportive.

Stakeholders unsupportive (n=17) of the Greenway being open 24 hours and lit 24 hours a day were given the opportunity to list their concerns around this proposal, and these are presented in Table 13 in Appendix 2. These 17 respondents were also asked if their concerns were addressed would they be supportive of the proposal, with 18% (n=3) saying they would be supportive, 53% (n=9) unsupportive and 29% (n=5) undecided.

### 3.10 Further Comments

At the end of the interview respondents were given an opportunity to make final comments on the Greenway. Additional comments made by residents are included in Table 9 in Appendix 2 with additional comments made by stakeholders in the online survey listed in Table 14 in Appendix 3.

### Section 4: Qualitative Research

#### 4.1 Introduction

As set out above it was agreed that meetings would be sought with individuals representing a range of interests. The consultation meetings were undertaken as semi structured discussions focussing upon the key issues of:

- Access.
- Lighting,
- Anti Social Behaviour,
- Health and Safety and
- Environment.

Consultees were encouraged to identify any perceived issues and perhaps more importantly options or solutions.

### 4.2 The Consultation Engagement Framework

In undertaking the consultation process it should be noted that the backdrop to the conversations was the comprehensive engagement framework established by the CCG engagement working group, and delivered by the Engagement Manager. In the context this meant that the issues raised had been well publicised and discussed in advance and therefore were not new.

It should also be noted that the consultation was being undertaken at a time of considerable public interest and a positive public perception of the project coinciding with the opening of the new Sam Thompson Bridge.

The following provides a summary of the findings summarised as key issues and proposed solutions.

### Section 5: Summary of Key Findings and Issues

#### 5.1 Introduction

The following section provides a summary of the key findings based upon a review of the primary and qualitative information.

### 5.2 Overall response to the CCG Project and the Linear Park

The overwhelming responses to the Linear Park and the issues raised were extremely positive. The Greenway is perceived as very positive development which will be an asset to the local area, East Belfast and more widely to Belfast. In those areas where the development is in evidence (specifically Orangefield and Victoria Park) the benefits are perceived in terms of the attractiveness of the area, the quality of the finish of the work ,the ease of access (particularly with respect to the opening of the Sam Thompson Bridge), and environmental improvements related to flood alleviation and appreciation

### 5.2.1 Access

Increased and open access along the spine of the CCG is not perceived in a negative manner by those consulted. Rather it is perceived as offering positive benefits to the area, in terms of access to work, health and educational benefits.

Any concerns that were raised relate to the possibility of closing off certain "flashpoints" in situations where trouble might arise. Such concerns might reflect existing issues in specified locations such as Flora Street, Bloomfield Parade, Beersbridge Road etc (i.e. trying to ensure any difficulties might be minimised).

### 5.2.2 Lighting

As above the principle of lighting from dusk to dawn is not perceived in a negative manner. The perceived benefits are seen to be related to access and in contributing to reducing any concerns related to anti social behaviour.

Any concerns that were raised related to the question of the potential of lighting to intrude on householders, contribute to light pollution or being of poor quality.

#### 5.2.3 ASB

The prospect of additional access did not raise any significant concerns re any related anti social behavioural issues. Concerns which were raised reflected current issues with regards to ASB activity in specific areas such as Avoneil Park and a fear that such activity could spill over. Equally any concerns were balanced by positive suggestions indicating how such activity might be curtailed and managed.

#### 5.2.4 Health and Safety

Easier accesses to rivers, waterways or bridges were not perceived as posing a significant risk and did not raise significant concerns. It was assumed that normal safety checks and warning signs would be put in place with the public exercising common sense

### 5.2.5 Environment

Here again the overwhelming response was very positive with the Greenway perceived as offering considerable benefits in terms of improved access , appreciation of the environment from the public, users school groups and community organisations. The positive benefits were also evident in terms of the flood alleviation work associated with the Greenway.



### 5.3 Scenarios, Solutions and Responsibility

Based upon the above it is possible to identify a number of possible scenarios and potential solutions as set out below:

#### **Section 6: Conclusions**

- 6.1 The Connswater Community Greenway is one of the most ambitious and significant developments in East Belfast for many years with the potential to inspire and transform the landscape and vision for all who live, work and visit the area. The delivery of the Greenway and it success to date has been based upon a partnership approach in terms of its governance, management and funding. A key element has been a commitment in principle and practice to a proactive engagement process, at every stage of development.
- As the project reached a critical stage of development towards the end of 2013 and the beginning of 2014 it was considered valuable by the Connswater Project Board to undertake an additional independent consultation process to identify any concerns or perceptions in relation to significant aspects of the principles underpinning the linear park in relation to access, lighting and any concerns that might exist in relation to anti social behaviour, environmental concerns or increased health and safety risks.
- 6.3 In January 2014 Blueprint and Social market research were commissioned to undertake the assignment based upon an agreed methodology. Building upon the considerable engagement work undertaken to date, this focussed upon three strands, firstly consultation with local stakeholders (community, voluntary, statutory and local government), secondly a household survey of 300 hundred residents and thirdly an online survey with stakeholders.
- 6.4 Based upon the work to date and the analysis of the qualitative and quantative research the following conclusions can be offered.
- 6.4.1 The Greenway as a concept and as it develops on the ground is overwhelmingly welcomed by respondents including consultees, residents and stakeholders. 75% of residents believe that the CCG is important to East Belfast, with 96% of stakeholders sharing this view.
- 6.4.2 There is a very high level of awareness and perception of the actual and anticipated benefits to the local area and East Belfast. The relates to the quality of life, improved access and amenities for families, improved access across the area and links to the City and access to work and employment opportunities. 72% of residents identified improving the quality of life for people in the community as a major benefit of the Greenway, with the same number identifying the following as major benefits: improving the environment in the local area; and, using the Greenway for walking.
- 6.4.3 The benefits of the engagement work already undertaken are reflected in the high level of awareness and in a desire for those consulted to continue to be informed and engaged. 68% of residents said they are 'very interested' or 'interested' in the CCG, with this rising to 97% for stakeholders.

### 6.4.4 Principles

There was overwhelming support for the key principles of access and lighting. Both the resident (94%) and stakeholder (88%) surveys recorded overwhelming support for the proposal to have the Greenway open 24 hours a day with 24 hour lighting along the main spine and throughout general areas of the Greenway.

#### 6.4.5 Access

There was very positive response to the issue of increased access opening up the linear park. Approximately nine out of ten (91%) respondents in the resident survey are either 'very supportive' or 'supportive' of the Greenway being open 24 hours a day, with 10% either 'unsupportive' or 'very unsupportive'. Overall 87% of stakeholders are either 'very supportive' or 'supportive' of the Greenway being open 24 hours a day. 75% of residents believe that opening the Greenway 24 hours a day will help promote positive use (70% of stakeholders shared this view).

### 6.4.6 Lighting

Providing lighting from dusk to dawn again received a very positive response from those consulted. It was seen as a cornerstone of increased access and contributing to a greater sense of personal safety and security. More than nine out of ten (94%) survey respondents are supportive of the main spine and general areas of the Greenway being lit 24 hours a day, with 6% unsupportive. Respondents living beside or a few streets from the Greenway recorded a significantly higher level of support (97%) for this proposal compared with those living further from the Greenway. More than nine out of ten (94%) stakeholders are supportive of the main spine and general areas of the Greenway being lit from dusk to dawn. 85% of residents believe that if the Greenway is lit 24 hours a day that this will improve people's sense of personal safety (82% of stakeholders shared this view).

### 6.4.7 ASB

This was identified as a potential area of concern. Not specifically linked to the Greenway or additional access rather to existing concerns with activities in specific locations which give rise to concerns. Again additional lighting, improved access and mitigating actions by PSNI and Council were identified as offering potential solutions.

#### 6.4.8 Environmental Concerns

The Greenway is perceived as offering positive benefits to the local environment and as an opportunity to improve access to and awareness of the local environment within Parks. Related to this the Greenway is perceived as offering a great resource to be exploited by local schools, clubs and societies.

### 6.4.9 Health and Safety Concerns

The Greenway, offering additional access to lakes or rivers, is not perceived as being a major source of concern. These were not considered a major concern rather there was a view that the normal health and safety checks would be put in place prior to and following the development phase.

### 6.5 Responses and Positive Action

One of the key areas of interest during the consultation was to identify responses or possible solutions to the issues identified. During the consultation and surveys a number of very positive proposals were made which have been summarised below. Significantly many of the suggestions are very practical, relatively low cost and easily implemented.

#### **Local Ownership and Engagement**

This may be seen as a key element in seeing the Connswater adopted by the community and visitors. This may be achieved through a variety of approaches including:

- A Programme of activities /outdoor events, summer and winter including Arts events
- Get together with local mums and tots groups and encourage a Buggy Push, or Buggy fitness classes
- Disabled facilities and fishing
- Establishing a "Friends" Group
- Establishing cafes /ice cream parlours
- Sculpture Park, bird watching
- Better use of Victoria Park Lake
- Additional CCG staff

### Safety

- Additional Park wardens and police patrols
- Patrols by Dog Wardens
- Pedestrian crossings at all road junctions i.e. at Sandown road
- Contact numbers readily available and manned
- CCTV mobile units to monitor persistent dog fouling and antisocial gathering areas
- Safe cycling and road safety workshops for kids, teens and even adults.

### **Hygiene factors**

- Seating and benches picnic areas
- Cleanliness and maintenance bins, toilets
- Water taps
- Dog fouling needs to be addressed
- Managing the litter problem

### **Education**

Linking in with schools, clubs, societies, voluntary groups

#### Access

- Maps /directional signs
- Linking into to other areas cycling areas e.g., the lagan
- Extensive bicycle parking facilities on the shopping areas bounding the Greenway.
- The consultation process identified a very high and positive response to the Greenway and highlighted possible solutions to areas that may have given rise to concerns. This in part reflects the on going and high quality level of engagement being carried out by CCG and Council staff. Continuing and building upon this level of engagement will be a challenge to the CCG trust and Council going forward.
- 6.7 The positive response to the issues of additional lighting, and increased access is a strong indicator of support. Equally positive and helpful are the range of solutions and practical ideas which, if implemented, will help the Connswater bed in and be accepted as an asset to the area and East Belfast and the wider City.
