### 1 Relevant Background Information

In response to the tragic death in June 2010 of a young man in the River Lagan close to the Stranmillis Weir, DSD have erected a pole and life ring on the south bank of the river close to the Weir. While DSD have ownership of the River Lagan at this point, the bank falls within Council ownership at Lagan Lands East. This life ring is in addition to other life rings provided by DSD downstream from this point.

DSD have now requested that the Council enter into a formal agreement to document the installation on Council owned lands. The location of the pole and life ring are highlighted with a red circle along with Council ownership at Lagan Lands East shaded green on the map attached as Appendix 1.

#### 2 Key Issues

Terms for a licence agreement have been agreed with DSD. These terms include commencement on 5 November 2010 for a period of one year, with continuation on a month to month basis thereafter. DSD will also be responsible for installation, maintenance, repair and replacement of the life ring and will fully indemnify the Council.
