# 1 Relevant Background Information

- 1.1 The Parks and Leisure Committee at its meeting on 14 March 2013, received a report (copy attached as Appendix 1) outlining a proposal to utilise part of Flora Street Walkway to provide contractor's access and a temporary contractor's compound, in connection with replacement of a boundary wall at Avoniel Primary School/Nursery School.
- 1.2 The report sought Committee approval for the grant of a Licence Agreement (for approximately 10 weeks) to Maurice Flynn & Sons who are the contractor to Belfast Education and Library Board for these works. The Director of Property and Projects will provide a verbal update on the outcome of the Parks and Leisure Committee.

#### 2 Key Issues

Agreement.

2.1 The attached copy report and map refer to areas to be used for access and for a contractor's compound, at Flora Street Walkway. It is proposed these areas will be incorporated in a Licence Agreement between the Council and Maurice Flynn & Sons. It is proposed the Licence Agreement will be for a period of approximately 10 weeks subject to an agreed Licence Fee of £75 per week payable to the Council.

# Resource Implications Finance Licence Fee income of £75 per week. No revenue or capital costs to the Council. Human Resources Resources in Parks and Leisure, Estates Management Unit and Legal Services involved in agreeing detailed terms, drafting and completion of proposed Licence

# 3.3 Asset and Other Implications

The provision of a new retaining structure will stabilise the adjoining BELB site and prevent further collapse of the site on to the Council's land.

#### 5 Recommendations

Committee is recommended to approve the grant of a Licence Agreement to Maurice Flynn & Sons to allow access over the area hatched orange on the attached map and the establishment of a contractor's compound on the area outlined blue/green on the map for a period of approximately 10 weeks, at a Licence Fee of £75 per week and subject to detailed terms to be incorporated in a legal agreement to be drawn up by the Town Solicitor.
