## THE HOUSING (NORTHERN IRELAND) ORDER 1981

<u>NOTICE</u> is hereby given that the Northern Ireland Housing Executive, having its principal office at 2 Adelaide Street in the City of Belfast, in pursuance of its powers under Article 88D of the Housing (Northern Ireland) Order 1981, on 18th January 2016 made an Order, which will be submitted to the Department for Social Development for approval, ordering that the Public Rights-of-Way described in the Schedule hereunder be extinguished.


