matches at Larne. The Club has sought support from the Council to secure 'a home' but to date a solution has not been found.

- 3.3 Crumlin Star is seeking preferential use of Pitch 3 and the adjacent changing pavilion which would be in line with a sports development plan.
- 3.4 Crumlin star has proposed that the Council investigates the possibility of bringing Pitch 3 and the associated pavilion up to Intermediate League Standard which would enable the Club to play its home games at Strangford Avenue. A map of Strangford Avenue with pitch numbers marked is attached at appendix 2. The Club has indicated that, if successful, it would explore other investment options to enhance the facility. The Club propose that the Council will remain responsible for the maintenance of the pitch and that they would pay for use of the facility.
- 3.5 While this is very much a preliminary proposal a number of issues exist:
 - 1. It is a matter for the Club to liaise with the IFA (Intermediate League Committee) regarding the suitability of the facility and to establish what works if any are required;
 - 2. Planning consent may be required;
 - 3. It is a matter for the club to submit a proposal to the Council setting this out and how it would be funded;
 - 4. Officers view this as an investment in the Club rather than an investment in the asset; for example it will not improve the asset or increase usage;
 - 5. The pitch is already used and, should the Council agree to the proposal, it would be necessary to displace existing users and find alternative facilities;
 - 6. It would be necessary to consult with other park users regarding the proposal as it would restrict access to the space for local residents who may wish to use the open space for passive recreational purposes.

It is the view of Officers that Committee should note the report and authorise Officers to liaise with the Club to address the issues outlined above and any other matters that may arise. A report considering the proposal in more detail will be submitted at a future date.

For information, Members are reminded that a report outlining a request from Aquinas FC was considered by the Committee in August. The previous request seeks to improve the asset by investing in Floodlighting and a high level fence for the pitch 1 marked at appendix
