	Members will be	aware that the Braniel estate is located in outo	er East	Belfas	t and	came	
	within the Belfast	boundary under Local Government Reform.					

- 3.2 The transfer from Castlereagh included within the Braniel estate a playground and MUGA; a bowling green; community centre and an area of open space. These assets are now managed through the City and Neighbourhood Services Department.
- 3.3 Appendix 1 shows the location of the existing playground and MUGA which is located in an elevated position within the Estate. Members will appreciate that there is no surveillance and access is difficult, particularly for those with a disability or parents and carers with young children.
- Appendices 2, 3 and 4 are photographs of the existing units. The equipment is generally viewed to be functional and in good condition. Members will note some damage to the surface and indeed Officers would be of the view that the surface would benefit from being replaced which would generally brighten it up.
- 3.5 The residents group has asked that we consider relocating the facility further into the Estate in an area adjacent to the existing community centre.
- 3.6 Appendix 5 shows the existing bowling green, which is now used as a small football area. It is proposed that the MUGA be relocated to this location. Appendix 6 shows a relatively level area of open space adjacent to the community centre and it is proposed that the playground be relocated to this location.
- 3.7 As stated previously there is little natural surveillance and access can be difficult. In addition, and some residents have expressed safety concerns around letting children travel to the playground/MUGA unaccompanied, although there have been no reports of incidents.
- 3.8 Members will be aware that the newly formed City and Neighbourhood Services Department comprises elements from a number of former departments including Parks and Community Services. The relocation of the playground and MUGA closer to the community centre would enable a more integrated programme of community activity to be put in place. Officers are of the view that a relocation of these facilities would be beneficial to the community and would encourage and promote greater use of the assets.
- 3.9 While Officers would concur that the existing facility is not ideally located it is proposed that an information session be set up to discuss proposals with the wider community and

	establish support for it or otherwise; it will also provide an opportunity to identify other				
	proposals which Officers believe are under consideration within the community, such as a				
	full size football pitch.
