3.0	Main report		
3.1	Key Issues The Strategic Cemeteries and Crematorium Working Group is a Working Group of the People and Communities Committee which consists of an elected Member from each of the political parties.		
3.2	The minutes from the Strategic Cemeteries and Crematorium Working Group are brought before the Committee for approval.		
3.3	The key issues discussed at the 6 March meeting were:		
3.4	Update on Memorial Inspection Programme  Members noted the update provided on the memorial inspection programme which commenced in September 2016. To date inspections have been undertaken in Balmoral Cemetery, Shankill Graveyard and Clifton Street Cemetery. Inspections commenced in Section D in Roselawn Cemetery in February 2017 and will continue across the other sections in the coming months. Members also noted that there had been an increase in income since the Memorial Management Policy had come into effect in April 2016.		
3.5	Update on the trial use of shoring to address subsidence at Roselawn Cemetery  Members note the update that was provided on the shoring trial that commenced in May 2016.		
3.6	Charity nomination for the distribution of money received from the recycling of metals  Members were reminded of the process that had been put in place for the nomination of a charity to receive the money received from the recycling of metals and noted that Cruise Bereavement Care had been selected as the chosen charity to be nominated in March 2017.		
3.7	Research and benchmarking  Members were provided with background information on rising funeral costs and granted permission in respect of undertaking research, including a benchmarking exercise in regard to the provision of municipal funerals.
