Dear Sir/Madam,

RE: Extinguishment of Public Rights of Way at Jamaica Walkways, Ardoyne, Belfast, Order No. 1, 2017

The Northern Ireland Housing Executive made an Order on 20th March 2017 that certain Public Rights-of-Way within the undernoted area be extinguished. Approval for the extinguishment is at present being sought from the Department for Communities, Causeway Exchange, 1-7 Bedford Street, Belfast BT2 7EG.

The Extinguishment of Public Rights of Way at Jamaica Walkways, Ardoyne, Belfast Order No. 1, 2017 is required to remove public access at 2 alleyways: between houses numbered 16 and 18 Jamaica Road, and between houses numbered 2 and 25 Jamaica Road. This will enable gates to be erected to close off the alleyways and thus prevent further anti-social behaviour.

The Press Notice regarding the Making of the Order is enclosed together with a map showing the area affected.

If you wish to make any comments, could you please let me have them by the 21st April 2017.

I will write to you again to let you know the results of this submission.
