The developer has proposed Castlegowan Place for the other new street with a second and third choice of Castlegowan Square and Castlegowan Gardens

Belvoir Park LLP have proposed Ishbel Mews with Ishbel Court and Ishbel Close for a second and third choice. The naming of the road has been based around the history of the site itself and linked to the names of streets already approved, for example, Ishbel Gardens.
