	As indicated earlier, the event has been held at Barnett Demesne since 2004. The				
	Council has worked closely with the County Grand Lodge to ensure that the venue has				
	facilitated the holding of a satisfactory event.				
	The main concern is that the site be vacated as quickly as possible and be left in the same				
	state as prior to use, given that Malone House and the grounds are heavily used by others.				
	The County Grand Lodge has undertaken to ensure that litter is removed and that any				
	physical damage to the site is repaired to its original condition.

	County Grand Lodge book Malone House and the appropriate fee for hire of the rooms is				
	charged to County Grand Lodge. Legal agreements will be entered into in respect of issues
