### **Official Announcements**

Representatives of all Parties expressed solidarity with the Black Lives Matter campaign in light of the recent murder of George Floyd in Minneapolis, Minnesota.

Councillor Matt Collins proposed:

“The Council agrees to write to the Chief Constable of the PSNI, the Northern Ireland Policing Board and the Minister for Justice stating that the Council believes that all fines issued at the Black Lives Matter protests on Saturday, 6th June should be dropped and that there should be no recriminations for the organisers of the protests.”

As there was no seconder, the proposal was not put to the Council.
